Once the completed product information has been submitted the testing process is initiated. Upon successful completion of testing and an initial inspection, you will be issued a UL certificate and be authorized to use the UL mark on your kiosk(s)

After your product has earned the UL Mark, UL field representatives located worldwide will make periodic visits to each production facility to determine that your products continue to meet requirements. This rigorous program helps protect the integrity of the UL Mark.
